- It is my will/desire that my beloved wife ELIZABETH GILLIAM should have the benefit of my houses, plantation land during her widowhood . . . and the benefit of the following negroes, viz: Harry and his wife Hannah, Mat, Danel? (yellow) _____ Aggy, Nancy and a girl Rhoda, also 2 boys Isaac and Powell with their increase. It is my will that she should take as much of my stock, plantation tools household and kitchen furniture as may be necessary for her support during her widowhood together with a sufficiency of provision for the support of the plantation one year.
- At her death or marriage it is my will and desire that all of the above named negroes with their increase together with my lands and all of the stock, household and kitchen furniture tools and crops that may be on hand at the time, be sold by my executors and the proceeds arising therefrom equally divided among my children or their heirs or representatives as herein after

directed. It is my will/desire at my death that the remaining part of my stock crop plantation tools household and kitchen furniture that may be on hand after my aforesaid wife Elizabeth GILLIAM shall have taken so much thereof as be thought necessary for her support and use, be sold and the proceeds thereof equally divided among my children their heirs or representatives as herein after directed.

- It is my will/desire that my tract of land lying on the head of Halfway Creek in Buckingham Co be sold by my executors whenever they may think best and the proceeds thereof equally divided among my children etc.

GILLIAM and at her death that they should go to her children and if her children should not arrive at full age or die without issue then it is my will that the property hereby given together with its increase and all the other property she may receive on an equal division of my estate shall should revert back to my children equally division among them.
- I give to my son RICHARD H. GILLIAM the following slaves viz: Jack, Judy, Delaware and Martha also 2 beds and furniture which I have valued to him at \$872 to him and his heirs forever.
- I give to my son Edmund J. GILLIAM and Richard H. GILLIAM in trust for the benefit of my daughter ELIZA G. GILLIAM and the heirs of her body, the following negroes viz: Monroe, Louisa and Lucy. Also 2 beds and furniture which I have valued to her at \$932.
- It is my will/desire that the above negroes together with their increase should be held for the benefit of my said daughter Eliza and the heirs of her body in trust by my said sons E. J. GILLIAM and R. H. GILLIAM and at her death that they should go to her children and if her children should not arrive at full age or die without issue then it is my will that the property herby given with its increase together with all the other property she may receive on an equal division of my estate shall revert back to my other children equal division among them.
- It being my will/desire that all my children should share equally in the benefit of my estate the property given off to them by this my last will and testament I have valued to them at the time of receiving it and set it down to them arriving to that valuation and it is my will/desire that the several _____ thus set down as given to them above should be taken into consideration in the final division of my estate among m children free of interest so that all shall be made equal in such division and receive the same amount of my estate.

- ITEM: I lend to my daughter Ann Eggleston Baugh, when she arrives to eighteen years of age or marries my Negro Lucy and her three children Adam, Dolly and John, also one feather bed and furniture and a horse and saddle during the natural life of my said wife and at her decease it is my will that wherever may be remaining at that period of the property loaned to my said daughter Ann Eggleston Baugh shall revert to my estate again.

- Without prior approval of the Court, Elizabeth moved the family and Estate Property of Benjamin to Kentucky; leaving her Uncle William Blackburn responsible under bond to the Court for administration of the Estate, and without the ability to perform. William Blackburn took legal action to protect his bond.
- To the Honorable Judge of the Garrard [County, KY] Circuit Court in Chancery sitting, the orator, William Blackburn, complaining, showeth unto your honor that Benjamin Boatright, late of Powhatan County Virginia, departed this life intestate on the day of June, 1816 in said County of Powhatan, and on the 17th day of July 1816, Elizabeth Boatright, his widow, who is made defendant hereto, qualified as his Administratrix in the County Court of said County and then and there entered into an Administration Bond with George Mosely and your orator, as her securities in the penalty of \$5,000 dollars a copy of which bond for greater certainty is here exhibited marked Exhibit A.

Edward F. Baugh, Jr. having received an advancement . . . And we have allotted to him [Ed. A. Lynch] Biddy . . . and Eady . . . The remaining slaves were then divided into four lots and drawn as follows:

Lot No. 1 – Ike, a young man . . . and this lot to support old Molly . . . was drawn by Lucy Baugh Lot No. 2 – Henry, a boy . . . was drawn by Sarah A. Baugh Lot No. 3 – Abby, a woman . . . was drawn by Wm. H. Baugh

Lot No. 4 – Mat, a man, Nancy, a girl . . . was drawn by Isaac N. Cardozo"

"This indenture made . . . between Edward F. Baugh & Samantha O., his wife, of County of [blank] in the State of Mississippi of the one part, and Geo. Taylor of the County of Powhatan in the State of Virginia of the other part . . . in consideration of the sum of [\$138.25] . . . convey unto the said Geo. Taylor . . . a parcel of land . . . in the County of Powhatan . . . [79] acres . . . bounded on the north by the land belonging to the estate of Ferguson Taylor dec'd, on the east by the dower land by Mrs. Martha Baugh, on the south by the Middle Road, and on the west by the land of the said Geo. Taylor, it being the same tract or parcel of land which was allotted to the said Edward F. Baugh in the division of the real estate of his father Edward F. Baugh deceased . . ."

"... orator Edward F. Baugh that his father Edward F. Baugh Senr. departed this life in the County of Powhatan in the year 1838 without having made any last will and testament and

that administration upon his estate was granted by the County Court of Powhatan to Rich'd F. Graves, Esquire. That for many years previous to the death of your orator's father to wit from sometime in [Mar 1831] untill about [1 Oct 1835] your orator lived with his father in the capacity of an overseer under a contract with him by which he was to pay your orator one seventh part of the crop made upon the plantation for his services. That during the whole . . . period he faithfully discharged his duty as an overseer and about [1 Oct 1835] he left his father's employment with his consent and removed to the State of Mississippi, where he has ever since resided until the early part of 1841. That previous to setting out for the west he frequently made application to his father for a settlement of their accounts which was general postponed not from any unwillingness on the part of his father to come to a settlement but from some reason or other at the time, of a temporary character. That about the time of his leaving Virginia his father put into his possession a negro boy by the name of Albert which he valued to him at \$700 to the account of his claim against him. That he also gave him \$50 in cash and paid sundry other small sums of money for him an amount of which will be filed herewith before the trial of this cause. That at the time he received Albert his father promised to give him a bill of sale for him, which he expected to be able to procure, but which he neglected to do. That the said Edward F. Baugh departed this life suddenly in a fit of apoplexy in the year 1838 and at the November C[our]t following a friendly bill and ... as it would deem was exhibited in the County Court of Powhatan for a division and settlement of his estate. That in this bill your orator with a portion of the other children of the s[ai]d Edward F. Baugh were made plaintiffs, without any consent whatever on the part of your orator for that purpose, and a desire for a division of the estate was had and in pursuance thereof. The commission appointed for that purpose made a division of the slaves among his widow and children and returned the same to Powhatan County C[our]t which at the February term of said court was approved and admitted to record no exemption being filed . . . all of which will more fully appear by reference to the record of s[ai]d C[our]t a copy of which will be filed before the trial of this cause. All these proceedings took place during your orator's absence in a distant state, without his knowledge or consent, and the first information which he rec[eive]d as he now recollects was upon a short visit which he made to the State of VA in the year 1839 after the report of the division had been admitted to record. That it will appear by reference to the report of the commission who divided his father's negroes that said distribution was entitled to receive in slaves, property to the value of \$673.33. That the said commission wholly unapprized of the character of the claim by which he had received the boy Albert from his father, proceeded to value him as a part of the decedent's estate, and in the division made your orator account for him as an advancement, and actually bought by your orator in debt for the sum of \$46.67.... That your orator is not disposed to cast concern on the commissioners, all of whom are intelligent and honorable men, but his misfortune has been that they acted without a knowledge of the fact that his claim to Albert was not in the nature of an advancement by his father, but a sale to him in pay[men]t of his claim upon him for an actual debt.

... He therefore prays that Rich'd F. Graves the Adm[inistrato]r aforesaid, together with the widow Mrs. Martha Baugh, and Isaac N. Cardozo and Mahala his wife, Edward A. Lynch & Harriet his wife, Sarah A. Baugh, Wm. H. Baugh, and Lucy Jane Baugh be made defendants hereto and that they be compelled to answer the several allegations of this bill on oath and that your Honour will accord to him the relief before pray'd for and make such other and further order herein as justice and equity may dictate and the nature of his case may regain & grant all proper ..."

"The deposition of George Taylor . . .

- I live within half a mile of Edward F. Baugh, Sr. and that his son Edward F. Baugh lived with his father in the capacity of an overseer from the time he became of age till he moved to Alabama Mississippi.

Answer: I was, tho we seldom visited each other except on Sundays, and not very often in those days, though I frequently saw him during the week in the plantation.

Answer: I gave him \$300 cash for his interest in his grandfather's (Jno. Toney, Sr.) estate about the time he was fixing to start.

Question: Is not Edward F. Baugh (the Pltff.) your son in law, having married your daughter before he removed to the South & did you not act as his agent in the friendly suit for the division of his father's estate.

Answer: He did marry my daughter before he removed to the South and I did act as his agent in the friendly suit.

Question: Did not Edward F. Baugh, Jr. immediately he was apprised of the way the division was made object to it?

Answer: He did as soon as I saw him."

"The deposition of Samuel Drake . . .

That he lived within a mile and a half of Edw'd F. Baugh Sr. and that he was in the habbit of going there frequently, sometimes two or three times a week . . .

Question: Was Edward Baugh, Jr. frugal and industrious in his habit or otherwise while living with his father.

Answer: He was both frugal and industrious.

Question: When did Edward Baugh become of age & when did he leave his father & go to Alabama.

Answer: He sold it to George Taylor and agreeably to the date of the deed, it was on [15 Apr 1839]."

- 2nd. It is my wish, and I do hereby authorise my executors, whenever they may think proper to sell my Lot on Bolling Brook Street, and also my Interest in the Swift Creek Cotton Factory, to be applied to the payments of my debts if necessary, and they are authorised by me to make full and complete title in fee simple to the purchaser or purchasers of the same.
- 3rd. I give to my daughter Sarah W. Boisseau [#62851] a piece or parcel of Land which I purchased of James Roane lying in Bermuda Hundred in the County of Chesterfield, adjoining the Land of Epes, as also the tract of Land now belonging to her. I hope and trust that she will bear in mind the great contrast between her situation and that of her poor Brother and Sisters.
- 4th. After the payment of my debts, I lend to my loving & most dutiful, & affectionate wife dureing her life the whole of my estate both real & personal, the better to enable her to support and educate my four infant children, Thomas [#62853], Margaret [#62854], Mary [#62855] & Rebecca [#62856], after the death of my wife, it is my will and desire that the whole of the estate left her during her life, to be equally divided between my five children, Lucey A. Prentis, Thomas, Margaret, Mary and Rebecca should my wife at any time wish to advance to either of them, any part of the estate left her dureing her life, it is my will that she should do so, provided it does not exceed what might be considered their proportion of the estate. This confidence I have placed in my dear wife, confidently believing that she will do nothing to the injury of our dear children.
- Lastly. I do hereby appoint my wife executrix, as also Edw'd. H. Boisseau & James Prentis executors of this my last will and testament. The foregoing is wholely written by me and subscribed this 12th July 1820.

I, Adam Bough of the County of Wythe and the State of Virginia, being very infirm in body but of perfect mind and memory thanks be to God therefore: and calling to mind the mortality of my body and knowing that it is appointed for all men once to die, do make and ordain this my last will and Testament, that is to say princeably and first of all I give and recommend my soul into the hands of the Almighty God who gave his anoiny body to the dust, to be buried in decent christian burial at the discretion of my Executors nothing doubting but at the general Resurction, I shall receive the same again from God who gave it to me and at touching such wordly Estate as it hath pleased God to bless me with in this life, I give devise and dispose it in the following manner and from Imprimis. It is my will and I do order that in first place: all my Just debts and funeral charges be paid and satisfied.
- Item: I give and bequeath to my sons GEORGE [#500-37] and HENRY BOUGH [#500-39] all that tract or parcel of land where on I now live, to have and to hold the said land to the only proper use and beehoof of the said GEORGE and HENRY BOUGH their heirs or assigns and it is my will and order that the said GEORGE and HENRY shall while they live on the land that they Farm the said land as usually they have done and when the crop is en ... to divide it in the field or barn as they shall think fit themselves and to have equal parts of measure orchard, Barn and other conviences belonging to the plantation only that each man shall have his own house, as at the present. And if either the said GEORGE or HENRY BOUGH should, at some future day, choose to sell his part of the land, he shall not have a right to sell the same to any other person other than the other Brother who lives on the land with him if such Brother shall choose to purchase, but if he will not incline to purchase, the one choosing to sell shall be at Liberty to sell as he can and to convey the same in fee simple to the purchaser, who shall be entitled to one half of the said land and to be divided by quanitity and quality and if both my sons afore said shall choose to sell at once, they shall then jointly convey the land and divide the price in two equal moneys between them. And it is my further will and order that they said GEORGE and HENRY BOUGH shall keep all my stock of horses, cattle, sheep, and hogs on the plantation for the use of the said GEORGE and HENRY and to be disposed of or used as the said GEORGE and HENRY shall think proper and I do also give and bequeath to the said GEORGE and HENRY, my waggon and gear and and singular my household and kitchen furniture of every kind whatsoever together with my blacksmith tools and farming utensils, axes, grubbing hoes. And I do also give to my sons GEORGE and HENRY BOUGH whom I likewise constitute make and ordain my only and sole Executors of this my last will and Testament and all my Books and Book debts now belonging to me or which shall belong to me at my death.
- It is my will and order that my Executors do pay to GEORGE [#500-311], the oldest son of ADAM BOUGH [#500-31], deceased, the sum of Ten pounds in trade of any kind that may suit the circumstances of my Executors, at any time within two years after my decease. If the same shall be lawfully demanded by the said GEORGE BOUGH and of not ten at any time, when the said GEORGE shall call for it; but shall not recover the same with interest by reason of delay that may be occaisoned by the said GEORGE BOUGH and if the said GEORGE

BOUGH shall not demand the same within twenty years after my decease, that then my Executors shall not be subject to the pay and thereof at any time after until they shall choose to do.

- And it is my will and order that my executors pay to my daughter, CATHERINE STIFFY [#500-32], the sum of twenty pounds at any time within four years after my Death to be paid in horses, sheep, hogs or in any other species of Property that may suit my Executors or that they may choose to give.
- And also pay the sum of one dollar to each of the heirs of my daughter, BARBARA HOSIER [#500-33], on demand after my decease.
- And it is my will and order that my Executors pay to each of my Sons, LEONARD [#500-34], MICHAEL [#500-35], and JACOB [#500-36], the sum of twenty pounds each, that is to say twenty pounds to LEONARD BOUGH at any time within eight years after my decease and the like payment of twenty pounds to MICHAEL BOUGH at any time within ten years after my decease and the same to JACOB BOUGH, at any time within twelve years after my decease.
- And it is my will and order my executors pay to each of my Daughters, ELIZABETH [#500-38] and MARY [#500-3A], the sum of twenty pounds each at the time following, that is to say, twenty pounds to be paid to the said ELIZABETH at any time within fourteen years after my decease and the like payment of twenty pounds to MARY at any time within sixteen years after my decease.
- All and every of the afore mentioned payments to be paid in horses, cattle, sheep, or hogs, or any other kind of trade at its same value that my Executors may choose to give and where it shall appear by obligation or book account that any of my heirs aforesaid is indebted to me or to me or to my estate, that then my executors is hereby fully authorized to call upon such of my heirs and settle with them, and such heirs shall give my executors credit for whatever may appear to be due, which shall be considered, for so much being paid of the twenty pounds aforesaid; but my executors shall not be at Liberty to make any of my Heirs pay any Interest or any sum that may appear to be due to my estate from any of my Heirs.
- And it is my will and order that if any of my Heirs shall by any ways or means whatsoever attempt to make my executors pay money instead of trade aforesaid, that then my Executors shall pay the sum of twenty-five shillings in cash and shall be discharged from the payment of the aforementioned twenty pounds to any heir who shall so attempt to demand or ask for money instead of trade.
- And I do hereby attest, disallow, breake, and disannul all and every other former Testament, wills, legacies and Executors by me in any way before this time made; will, bequeath, testifying, and confirming this and no other, to be my last will and Testament.
