Old Esther, Little Ben , Alfred, Betsey, Franklin, Het (Easter’s daughter) , Caroline, & Lydia ( children of Easter) George Upham (Easter’s son and his wife Emma and her child Sarah) Old Hampton, Easter, Hampton’s wife & their 3 children, to wit: Ned, Osbourn, & Nancy, Henry & Sam Hampton’s children David Isom’s son, Brutus & Nell, also all the stock, farming tools, all crops now growing ( except the cotton ), all provisions with all the household, the future increases of everything on said plantation to be managed by Robert Ellis, Trustee. The net proceeds are to be paid to Mariah McDonald annually as long as she may live and at her death to be divided among her then living children. I leave in the hands of my executor the sum of \$300.00 to be applied to the repairing of our family burying ground on the plantation whereon my aunt Judith Ellis now lives. He is to procure a decent set of marble tombstones for my father, mother & brother Henry for my grave. Should it not take all to execute the work above named, the balance is to be kept at interest & the interest applied to the repairs of the said graveyard as it may need it. To the trustees of the Jersey Settlement Meeting House the sum of \$200.00 to help complete the new Church now in building. To Mary Ellis, who is I suppose is my wife-in law- the sum of \$5000.00 which is to be full of all the part which she & her child now at her breast are to have. To John A. Bradshaw [#41251], son of Austin Bradshaw [#4125], my gold lever watch. I will that Alexander, Jane, Amanda, children of Molatto Eliza, bought of John A. Chaffin by my brother Henry, deceased, & by his bequeath to me remain in my estate & that my executor to have full power to convey them to a free state in order to set them at liberty so that they, Alexander, & Jane Amanda may have their full freedom & when they arrive in a free state that the expenses of conveyance & \$100.00 to each one of them be paid out of my estate. I will that my executor sell my negro woman Eliza, willed to me by my brother Henry, deceased, also my tract of land lying below Bradshaw’s Mill, adjoining the lands of David Smith & the lands of John L. Hargrove, deceased, together with all my personal property of ever description, negro slaves excepted, on all my plantation in Davidson Co. on a credit of 12 months & after paying all my just debts. & the bequest in this will, the residue of said sale, together with all my cash which may be on hand & notes & accounts be divided equally between the following persons: My cozens Robert Ellis, son of John Ellis,

deceased, John W. Ellis, Sarah Ann Elli, Mary Jane Ellis, & William Anderson Ellis children of Anderson, deceased. I also give to the said Robert Ellis, John W. Ellis, Sarah Ann Ellis, Mary Jane Ellis & William Anderson Ellis all my lands in Davidson County, lying continuously on Swearing Creek, Potts Creek, known as the Jersey Lands. Also my Negroes in the County of Davidson now living on said lands are to be divided equally. I empower my executor to sell the interest which I have in the store of Holmes & Ellis at the Washington Mine at per cost privately on a credit of 6 months, and the proceeds of which to go into my estate & to be divided as above directed, also the interest in the notes & accounts or cash to be divided in the same way.”

It is my will that my family live together and that all the property not devised to remain on my Plantation in the care of my beloved wife Judith Ellis to be managed to the best advantage until my son William Anderson Ellis shall arrive of full age at which time I wish all of my personal estate consisting of negroes, horses, cattle, hogs, & sheep, farming utensils & all other personal estate divided equally amongst the following legatees to wit, my wife Judith Ellis, Elizabeth Pearson, Mariah, Lucy, John, Sarah, Mary, and William Anderson Ellis so as to make them all equal in my personal estat, but if my wife should die before my son Wm. Anderson arrives of full age then the property to be divided as soon as can be.  
I give to my two sons John & William Anderson Ellis on Wm. Anderson arriving of full age my tract of land which I purchased of Elizabeth M. Kelley containing about Eight Hundred acres to be equally divided between them both to them and their heirs forever, but should either of them die without issue then the surviving brother to heir all the above named Kelly Tract.

I give to my beloved wife Judith Ellis during her natural life one third part of the tract of land whereon I now live supposing to contain five hundred & sixty five acres her part to include my mansion house and all my other buildings, also the spring also the following negroes to wit, Dice and her children Harry, Peggy, Cloe, and Charles.

It is my will that my executors sell the whole of my mill lands supposed to contain Twenty Seven Hundred acres either privately or at public sale on a credit for the best price which can be obtained. The money arising from said sale to be equally divided between my daughters Harriett Bradshaw [#4125/1], Elizabeth Pearson, Mariah, Lucy, Sarah, and Mary but if said land cannot be sold for something like a fair price then my executor is to pay as soon as it can be made by the crops which may be hereafter raises to Elizabeth Pearson, the sum of Two Thousand Dollars which is to be in full of her part of said land, and whenever said land can be sold the proceeds thereof to be equally divided between the following children to wit, Elizabeth Pearson, Mariah, Lucy, Sarah and Mary Ellis.

I will that my executor sell my tract of land whereon I now live after the death of my wife either privately or at public sale for the highest price the money arising from said sale to be equally divided between the following children to wit, Elizabeth Pearson, Mariah, Lucy, Sarah and Mary Ellis.

If any of my children should die without issue then & in that case all the property which they may have heirs by this will shall fall back into my estate, and belong to my other heirs.

I authorize nominate & appoint my nephew James Ellis sole executor of this my last will & testament hereby revoking and disannulling all former by me made.
