Description: "At the August Term of the County Court . . . for the year [1836], an motion of Wesley Cole, said Cole then being the Administrator of said Estate, it was ordered and decreed by said Court that the Administrator issue the real estate belonging to said Estate . . . to the highest bidder . . . to be holden at Union on the first Monday of November next, consisting of the following tract of land, to wit, [SW¹/₄ of Section 17, T44N R1W] . . . containing [160] acres [in Franklin Co.] . . . being the same tract purchased from the United States . . . between New Port and Washington on the rode leading to St. Louis adjoining the Mill Tract belonging to Benoni Sappington in about a quarter of a mile from the mill . . . did openly sell the property above mentioned to the said Perry Cahill, he being the highest bidder for the same for [\$633]"

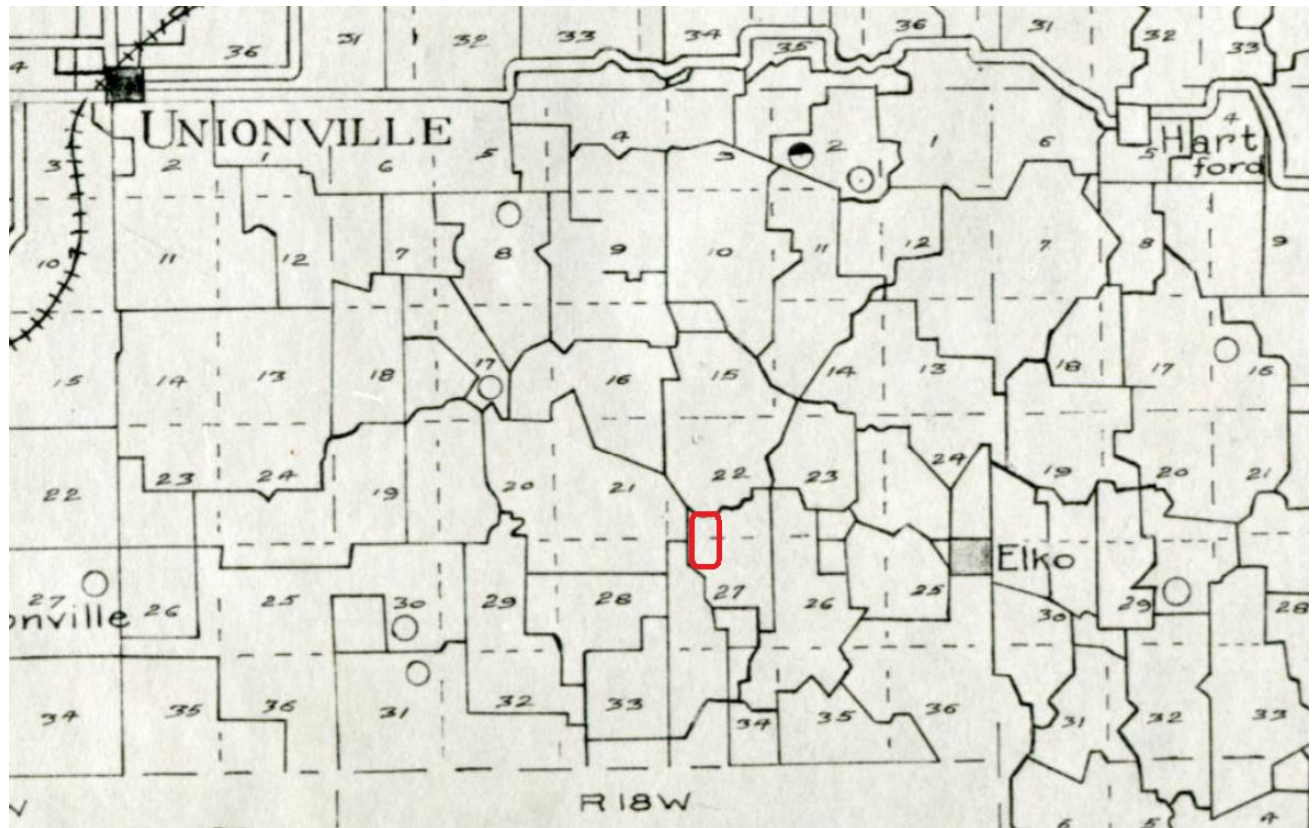

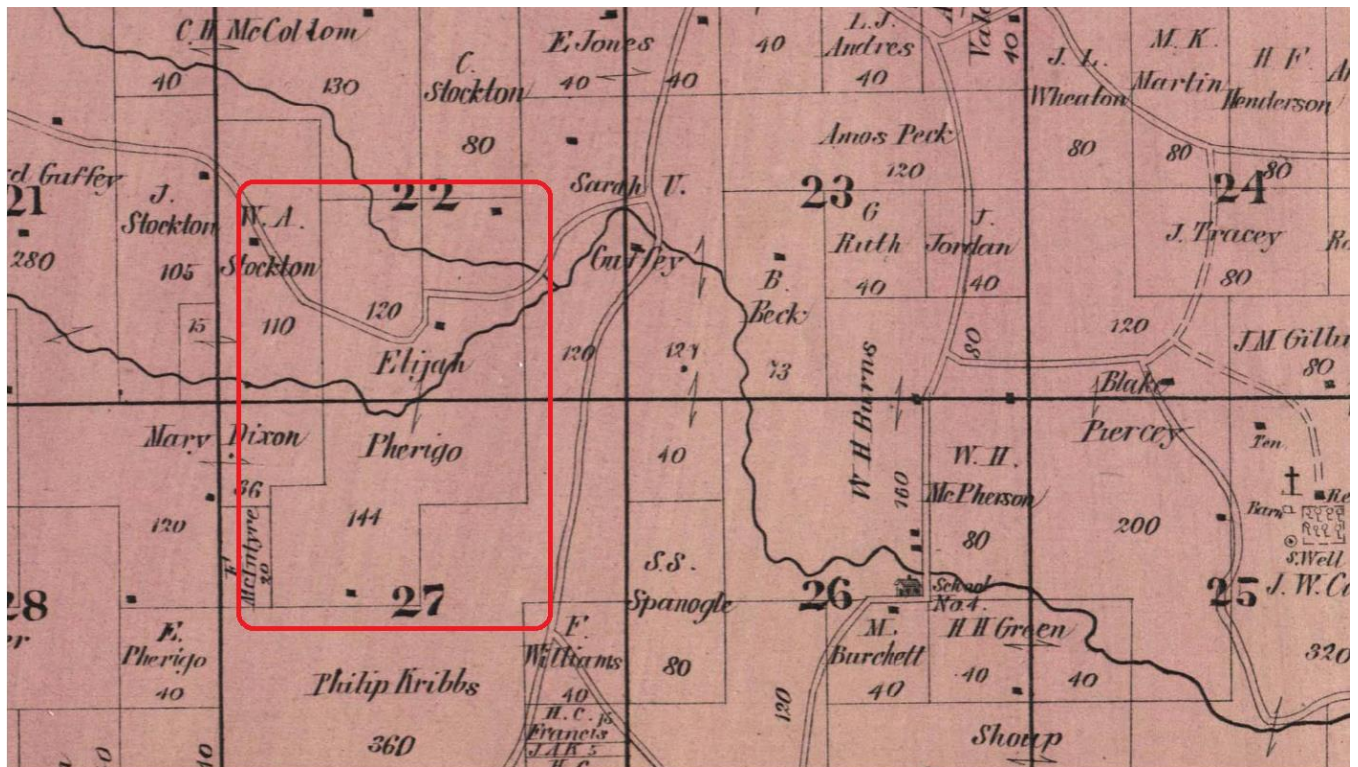

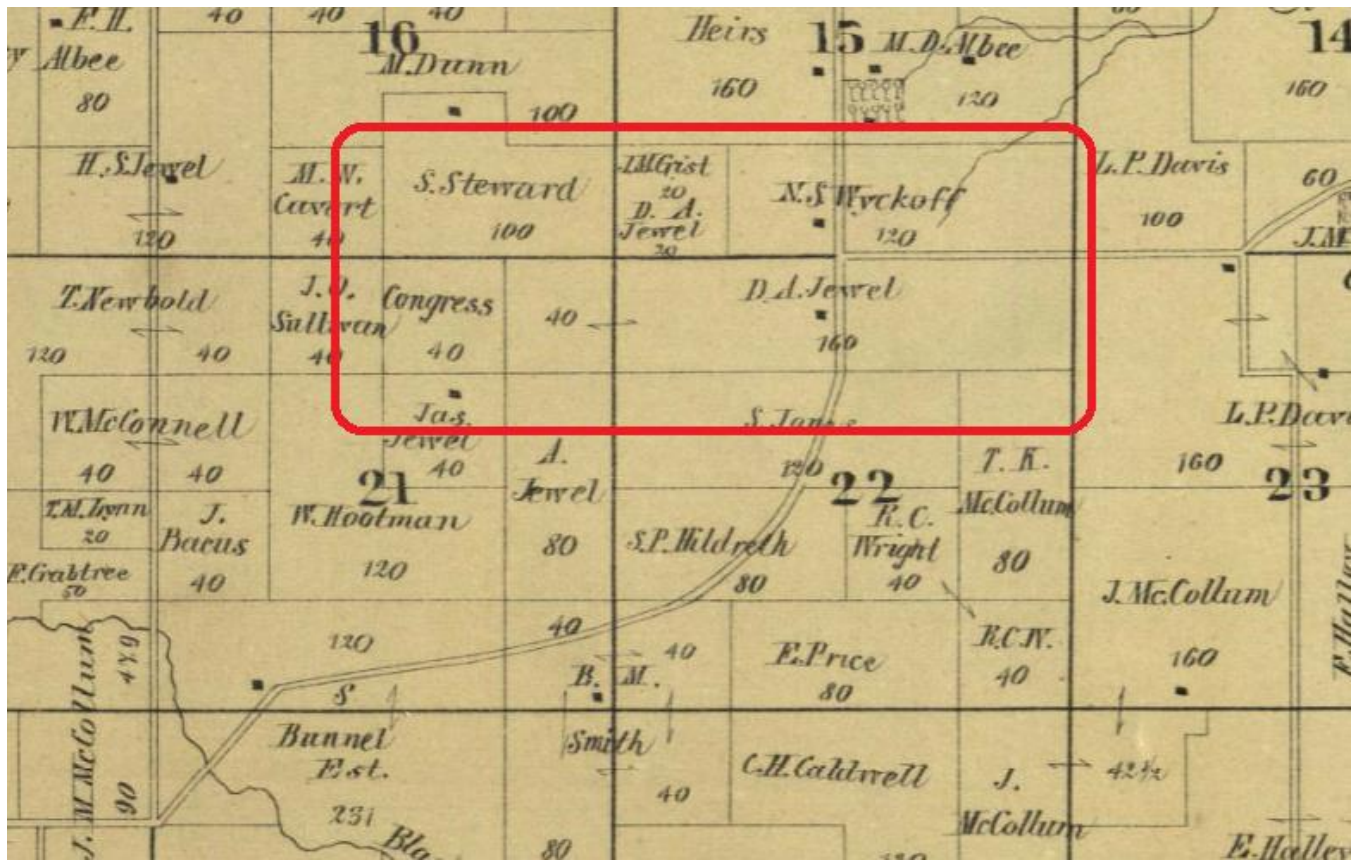

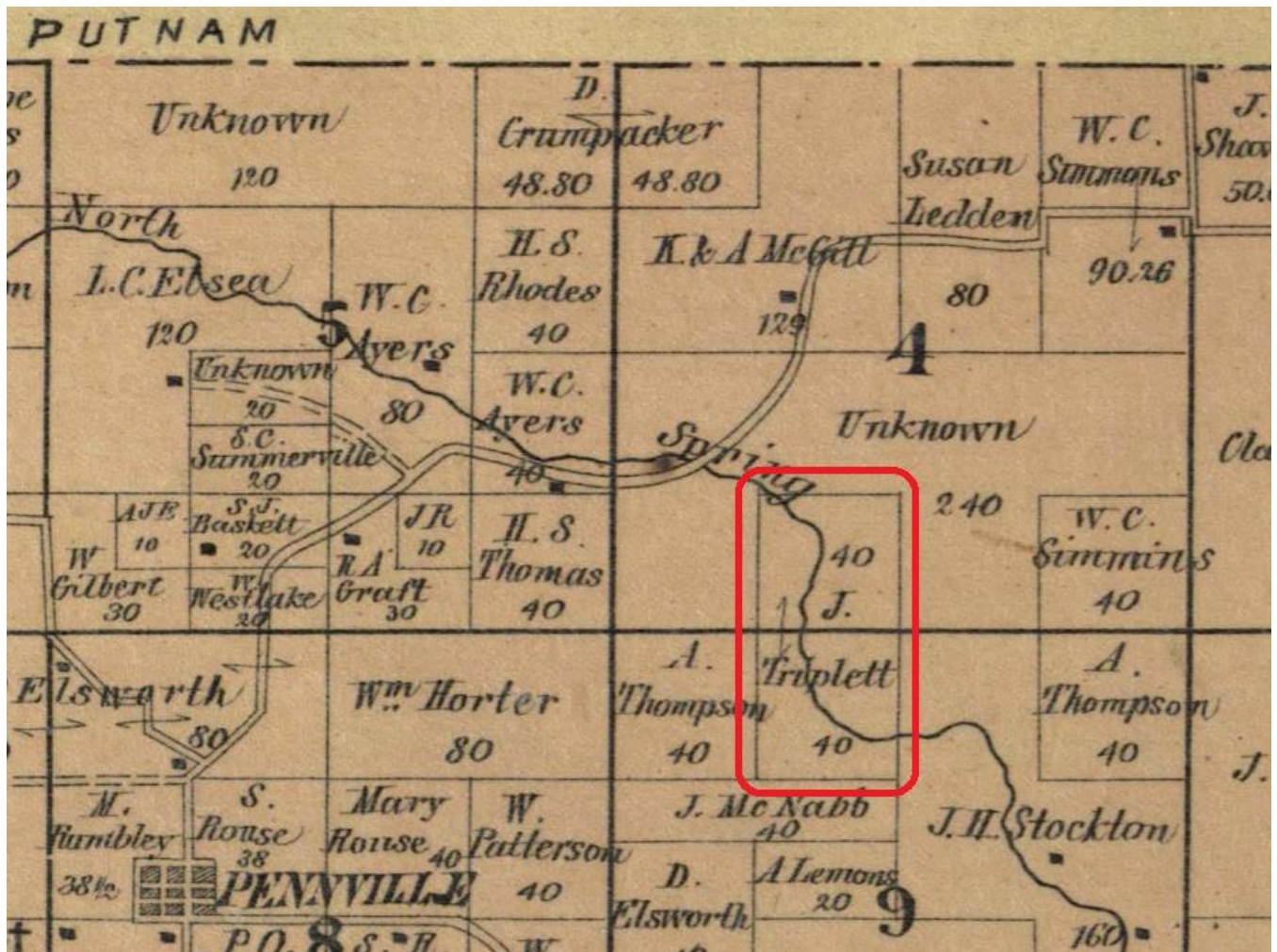
