George A. Smith & others, widow & heirs of Isaac Williams, dec'd (Plaintiffs) against

Sinett Triplett [#23721] & others, widow & heirs of Hedgman Triplett [#2372], dec'd (Defendants)

It appearing to the Court that the Plaintiffs have regularly proceeded against the absent Defendants Robert Trimble [#23727/1] and Susan [#23727] (his wife) and Samuel Williams [#23722/1] and Benedicta [#23722] (his wife) by publication according to the act of assembly and the rules of this Court and more than four months having elapsed since the filing of the Plaintiff's bill, & the service of the subpeona in this cause upon the Defendant Mary Triplett [#2372/1] & they still failing to appear and answer the Plaintiff's bill. On the motion of the Plaintiff's, it is ordered that the matters & things in the Plaintiff's bill contained be taken for confessed as to them, and this cause came on this [16 Oct 1832] upon the bill answers of the Defendant Sinett Triplett, Amelia Triplett [#23726], Williams S. McClenachen [#23723/1] and Elizabeth [#23723] (his wife), Robert Duffield [#23724/1] & Mary [#23724] (his wife), Elias Dowell [#23725/1] and Nancy [#23725] (his wife), and Hedgman Triplett [#23728], and the answers of the infant Defendant Marshall Triplett [#23729] by William Cary, his Guardian ad litem, exhibits and the report of the Commissioners . . . appointed by an order of this Court of [10 Jun 1831] to survey and lay off, the several tracts of land in the bill in equal portions according to quantity and quality and situation agreeably to their respective rights . . . On consideration whereof, and it appearing to the Court . . . that the three tracts of land . . . are found to contain [11,280] acres, that the two tracts containing [10,630] acres, are one divided into two equal moieties . . . designated on the plat & report by Nos. 1 & 2. That division No. 1 in equal portions . . . has been assigned to the widow and heirs of Hedgman Triplett, dec'd, except Sinett Triplett, and division No. 2 . . . has been assigned to the widow and heirs of Isaac Williams, except George A. Smith & [blank] (his wife) and that the tract of 650 acres has been divided into two equal moieties, one of which containing [325] acres they assign to Sinett Triplett, and the other of like quantity they assign to George A. Smith & Ophelia (his wife) . . .

That Lot No. 5 containing [13] & [72] [1,372 ?] acres be assigned to John M. Patton & Peggy (his wife) . . .

That Lot No. 3 containing [1,139] acres be assigned to Daniel F. Slaughter & Robert M. Patton or the survivor of them as Trustees for Isaac H. Williams for the benefit of Robert M. Patton .

That Lot No. 4 containing [901] acres be assigned to Mary Elenor Williams . . .

And that Lot No. 2 containing [1,221] be assigned to John I. Williams . . .

It is further adjudged, ordered, and decreed that [blank] Williams, widow & relict of Isaac Williams, dec'd, do hold quiet and peacible possession of the lot containing [1,267] acres assigned to her by said Commissioners for and during her natural life, as and for her dower in the one moiety of the land . . .

That Lot No. 1 containing [325] acres, being one moiety of the 650 acre tract, be assigned to Sinett Triplett . . . that Lot No. 7 containing [767.75] acres in moiety No. 1 of the [10,630] acres be assigned to Samuel Williams and Benedicta (his wife) . . .

That Lot No. 6 containing [660.5] acres be assigned to Wm. S. McClenachan & Elizabeth (his wife) . . .

That Lot No. 4 containing [224.75] acres be assigned to Robert Trimble & Susan (his wife) . . .

That Lot No. 5 containing [573.5] acres be assigned to Amelia Triplett . . .

That Lot No. 3 containing [300.5] acres be assigned to Robert Duffield and Mary (his wife) . . .



That Lot No. 2 containing [169] acres be assigned to Hedgman Triplett . . .

Beginning on Henderson's line and running . . . E. to the spring below the Horse Mill and the same line continue to the back line from that . . . to my son Robert's 71 acres . . .

Give and bequeath unto my son Alfred [#23777] 100 acres of land, joining of Frances, running parallel line with his line . . .

And all the remainder of my real and personally Estate to be equally divided between my three daughters and my son John [#23778], Benedicta [#23772], Frances [#23774], and Ann [#23775], except . . . acres which I bequeath to my son Burr [#23771] the blacksmith tools.
